# **HCPCS Code Updates for Home Health Care Services**

### Purpose of this communication:

• To notify home health providers that services associated with a subset of S and T codes must be registered and billed with the new respective HCPCS for dates of service on or after July 1, 2022.

#### What do I need to know?

- When registering a service with CareCentrix with a date of service on or after July 1, 2022, utilize the new HCPCS codes listed below.
- Providers are not required to update service registrations.
- The new HCPCS codes replace the previous codes and do not require modifiers.
- The following HCPCS codes are affected by this change:

### What do I need to do?

- Providers should continue to submit claims using the listed previous S or T HCPCS codes when the date of service billed on the claim is **prior to** July 1, 2022.
- Providers should submit claims using the new listed HCPCS codes when the date of service billed on the claim is **on or after** July 1, 2022.
- For a claim line with a date span that starts prior to July 1, 2022 and extends through or beyond July 1, 2022, use the S and T codes.
